3. That the Township shall fund said award through its 2024 budget, Legal services O/E in the amount of \$37,229.39 per annum. No amount of any contract shall be chargeable until certification of available funds are made and upon receipt of a properly executed Purchase Order pursuant to the rules of the Local Finance Board of the State of New Jersey.
