FINANCE:

Mr. Thomas Welsh – Suggested the sprinkler system in Town Hall be inspected. Normally inspected on an annual basis. Noted that the sprinklers are not connected to any alarm systems. Seven new inspections, four re-inspections, and four other pending inspections. He will be dealing with various complaints the next few days, parking issue and an unleashed dog complaint.
