RESOLUTION TO AUTHORIZE EXTENSION OF SHARED SERVICE AGREEMENT BETWEEN THE BOROUGH OF RED BANK AND THE TOWNSHIP OF SHREWSBURY FOR THE SHARED USE OF THE MUNICIPAL COURT

WHEREAS, the Uniform Shared Services and Consolidation Act, <u>N.J.S.A.</u> 40A:65-1 et seq. authorizes municipalities to contract with each other for Shared Services; and

WHEREAS, the Borough of Red Bank ("Borough") entered into a shared service agreement with the Township of Shrewsbury ("Township") on December 4, 2013 for the sharing of the Municipal Court, facilities, personnel and services of the Borough on behalf of Shrewsbury Township for an annual fee of \$9,000.00 per year for a period commencing January 1, 2014 and terminating December 31, 2017, and the parties are presently renegotiating the aforesaid Agreement, and an extension of time on the existing Agreement is necessary in order to accomplish completed negotiations.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Shrewsbury, County of Monmouth, State of New Jersey, that the Mayor and Township Committee hereby authorizes an extension of the 2014 Shared Service Agreement between the Borough of Red Bank for a period of three (3)

months (from January 1, 2018 – March 31, 2018) under the same terms and conditions as the 2014 Agreement, with the annual fee apportioned based on a monthly basis for the three (3) month extension.
