RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF
SHREWSBURY AUTHORIZING THE APPOINTMENT OF A CERTIFYING
OFFICER AND SUPERVISOR OF THE CERTIFYING OFFICER FOR THE
PUBLIC EMPLOYEES RETIREMENT SYSTEM FOR THE YEAR 2017**

WHEREAS, the Department of Treasury, Division of Pensions & Benefits, requires that there be a designation of a certifying officer and supervisor of the certifying officer for the Township; and

WHEREAS, "Certifying Officer" is defined in the New Jersey pension law to mean an officer or employee of the State or of an employer other than the State who is responsible for submitting information to and performing the duties relating to matters concerning the retirement system with respect to each of the employees of the employing location, as required by law, the board of trustees or commission, and the Division of Pensions and Benefits, and

WHEREAS, "Supervisor of the Certifying Officer" is defined in the New Jersey pension law to mean the immediate supervisor of the certifying officer,

WHEREAS, the Township of Shrewsbury would like to name Joanne Pavao Administrative Assistant, as the certifying officer, and Suzanne M. Veitengruber, Business Administrator/CMFO, as the supervisor of the certifying officer for the year 2017.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Shrewsbury, County of Monmouth, and State of New Jersey, as follows:

1. **Suzanne Veitengruber** is hereby designated as the supervisor of the certifying officer for the Public Employees Retirement System on behalf of the Township of Shrewsbury for 2017.
2. **Joanne Pavao** is hereby designated as the certifying officer for the Public Employees Retirement System on behalf of the Township of Shrewsbury for 2017.
3. That upon the adoption of the within resolution, the Clerk is authorized and directed to forward a certified copy of it to the Department of Treasury, Division of Pensions & Benefits and Suzanne Veitengruber and Joanne Pavao.
